MINUTES OF MEETING TUESDAY, February 18, 2020

## Meeting called to order @ 7:30 by Cheryl S 52 members & quests present

Presentation of checks to our 2019 chosen charities.

\$1590 each was presented to Marilyn M, representing For the Troops and Diane B, representing Simi Valley Spay & Neuter Clinic. Both told a bit about their organization. Marilyn reminded members about the upcoming FTT Gala at the Reagan Library on Saturday. Donations for silent & live auction. Jim H brought in a beautiful Adirondack chair he made and donated. Diane discussed how their mobile unit and "no-kill" storefront clinics spay & neuter stray dogs & cats. Bake Sale. Thank you to Debbie C. She also donated a bag of cookies which Patrick auctioned off. Cookies were won by guest Amy H from the National Corvette Museum. [ps...no one has signed up for next meeting]

<u>Approval of Minutes from Last Meeting – Lois F, Secretary</u>: Lois announced corrections from last meetings minutes. In "Share the News" Lois misspelled the initials COTA (as KOTA), not realizing they meant *Circuit of the Americas [oops, I'm not into racing, sorry]*. No further corrections or additions were mentioned. Motion to accept minutes as corrected made by **Sherrie N**, 2<sup>nd</sup> by **Frank C** and accepted by members present.

<u>Guest & Member Recognition</u> – Bob S, Vice President. Bob recognized our guest Amy H, Director of Philanthropy, from the NCM. Amy signed our guest book.

<u>Treasurer's report</u> – Patrick N, Treasurer. Patrick gave the financial report. Current balance is \$17,847. He then called for a motion to accept the 2019 Financial Report and 2020 Balanced Budget. Motion was made by **Frank C** and 2<sup>nd</sup> by **Bryan P** and accepted by members present.

Patrick announced that the annual Audit will be conducted on the 2019 by Members **Reggie L**& **Lyell H** (no audit has been conducted for the last 2 yrs.) at the Santor's home.

The financial report concluded with the announcement that we currently have revenue in our account of \$577. With that, he called for a motion to accept the current financial report. Motion was made by **Sherrie N**, 2<sup>nd</sup> by **Steve R** and accepted by members present.

Patrick showed his purchase of Hot Wheel Stamps he recently purchased. They were passed around to view. [he almost didn't get them back]

Also, he acquired a beautiful Like-New Leather Jacket and Corvette coffee table book donated by Mike Neveaux. Will discuss with E-Board best way to auction the items for our 2020 charities (to be chosen next month) Lois will send a thank you note. See photos on page 6.

<u>National Corvette Museum</u> – Cheryl S, NCM Ambassador - Cheryl introduced Amy H, the Director of Philanthropy, from Bowling Green, KY. Amy first gave an update on NCM activities. Wendell Strode, NCM president/CEO has retired and Dr. Sean Preston has taken the position. Upgrades are being made to the Performance Gallery. An exhibit of Car-Toons and the influence of designs by Ed "Big Daddy" Roth, creator of Rat Fink. Exhibit also includes some Transformer Cars (from the movie). Rich Bongeorno asked if they had the green one or silver one on display. Yes, to both.

Amy discussed the desire of the museum to own its vehicles on display as opposed to having them be on loan. A unique vehicle has become available to the museum and Amy presented the opportunity to the club members to individually make donations in honor of the club of this car: The XP987, a mid-engine prototype offered for purchase to the NCM (photos on p. 7). The total amount of donations would need to total \$25,000 over a period of 5 yrs. for the club name to attached as sponsor of this car.

Tours of the factory to be resumed probably in April. C8 will be available to drive at the NCM Motorsports Park.

Amy presented Cheryl with an NCM Club Presidents' Pin.


